



MANAGEMENT'S DISCUSSION AND ANALYSIS

THREE and NINE MONTHS ENDED September 30, 2022

1. Introduction

The following management's discussion and analysis ("MD&A") of the financial condition and results of the operations of GPM Metals Inc. ("GPM" or the "Company") constitute management's review of the factors that affected the Company's financial and operating performance for the period to September 30, 2022. This MD&A was written to comply with National Instrument 51-102 – Continuous Disclosure Obligations requirements. This discussion should be read in conjunction with the Company's audited annual consolidated financial statements for the years ended December 31, 2021, and 2020, together with the notes to that. Results are reported in Canadian dollars unless otherwise noted. The Company's consolidated financial statements and the financial information contained in this MD&A are prepared under International Financial Reporting Standards ("IFRS") as issued by the International Accounting Standards Board ("IASB") and interpretations of the IFRS Interpretations Committee ("IFRIC"). Information contained herein is presented as of November 22, 2022, unless otherwise indicated.

To prepare this MD&A, management, in conjunction with the Board of Directors, considers the materiality of information. Information is considered material if: (i) such information results in, or would reasonably be expected to result in, a significant change in the market price or value of GPM common shares; (ii) there is a substantial likelihood that a reasonable investor would consider it important in making an investment decision; or (iii) it would significantly alter the total mix of information available to investors. In conjunction with the board of directors, management evaluates materiality with reference to all relevant circumstances, including potential market sensitivity.

3. Description of business

GPM is a Canadian-based exploration and development company. Its principal mineral assets at the date of this MD&A are as follows:

The Company, through its wholly-owned subsidiary DPG Resources Australia Pty Limited ("DPG Pty"), has entered into an Earn-In/Joint Venture Agreement with Rio Tinto Exploration Pty Limited ("Rio Tinto"), a wholly-owned subsidiary of Rio Tinto Limited covering base metal exploration and development rights with certain granted exploration tenements and tenement applications in McArthur Basin Mining District, Northern Territory, Australia (the "Walker Gossan project"). Rio Tinto and GPM have entered into a definitive Two Stage Earn-In/Joint Venture Agreement granting GPM an initial 51% interest under certain conditions.

The Company is a reporting issuer in British Columbia, Alberta, and Ontario and trades on the TSX Venture Exchange (the "TSXV") under the symbol "GPM."

Overall objective

The Company is a junior mineral exploration company with an experienced management team engaged in the acquisition, exploration, and development of properties for mining minerals. GPM is in the process of exploring its mineral properties and has not yet determined whether these properties contain any economically recoverable mineral reserves. The success of the Company is dependent upon the existence of economically recoverable mineral reserves, the ability of the Company to obtain the necessary financing to complete exploration and development of its properties, the selling prices of minerals at the time, if ever, that the Company commences production from its properties, government policies and regulations and future profitable production or proceeds from the disposition of such properties.

GPM has not discovered economically recoverable mineral reserves. While the discovery of ore-bearing structures may result in substantial rewards, it should be noted that few properties that are explored are ultimately developed into producing mines.

3. Description of business continued

The Company may also seek to acquire additional mineral resource properties or companies holding such properties. The Company notes that mineral exploration, in general, is uncertain, and the probability of finding economically recoverable mineral reserves on any one of its early-stage prospects is low. As a result, the Company believes it can reduce overall exploration risk by acquiring additional mineral properties. In its search for other mineral properties, the Company may consider acquiring properties that it considers prospective based on criteria such as the exploration history of the properties, their location, or a combination of these and other factors. Risk factors to be considered in connection with the Company's search for and acquisition of additional mineral properties include the significant expenses required to locate and establish economically recoverable mineral reserves, the fact that expenditures made by the Company may not result in discoveries of economically recoverable mineral reserves, environmental risks, risks associated with land title, the competition faced by the Company and the potential failure of the Company to generate adequate funding for any such acquisitions. See "Risk Factors" below.

4. Changes in accounting policies

Future changes in accounting policy are not yet effective as of September 30, 2022.

At the date of the authorization of these consolidated financial statements, the following revised IFRS standards, which apply to GPM Metals Inc., were issued but not effective yet.

- i. Deferred Tax related to Assets and Liabilities arising from a Single Transaction (Amendments to IAS 12) – effective for year ends beginning on or after January 1, 2023. The amendments specify how companies should account for deferred Tax on transactions such as leases and decommissioning obligations and clarify that the initial recognition exception does not apply to transactions where both an asset and a liability are recognized in a single transaction. Accordingly, deferred Tax is required to be recognized on such transactions
- ii. Definition of Accounting Estimates (Amendments to IAS 8) - effective for year ends beginning on or after January 1, 2023. The amendments introduce the definition of accounting estimates and include other amendments to IAS 8 to help entities distinguish accounting estimates from changes in accounting policies.
- iii. The materiality of Accounting Policy Disclosure (Amendments to IAS 1) - effective for year ends beginning on or after January 1, 2023. The amendments require companies to disclose their material accounting policy information rather than their significant accounting policies.

The Company is currently assessing the impact of these standards on its consolidated financial statements.

5. Exploration highlights

The Company's exploration activities are at an early stage, and it has not yet been determined whether its properties contain an economic mineral reserve. There are no known deposits of minerals on any of the Company's mineral exploration properties, and any activities of the Company thereon will constitute exploratory searches for minerals. See "Risk Factors" below.

Walker Gossan Project, McArthur Basin Mining District, Northern Territory, Australia

Ownership Interest Description

Earn-in/joint venture agreement

In January 2014, the Company, through its wholly-owned subsidiary DPG Resources Australia Pty Limited, entered into an Earn-In/Joint Venture Agreement with Rio Tinto covering base metal exploration and development rights with the Walker Gossan project.

Rio Tinto and GPM have entered into a definitive Two-Stage Earn-In/Joint Venture Agreement granting GPM an initial 51% interest under certain conditions that include:

Stage One

1. Payment of Australian Dollar ("AUD") \$1,000,000 on signing (paid);
2. Minimum expenditure of AUD 2,000,000 within three years of the effective date (met);
3. Combined expenditures of AUD \$20,000,000 over a 10-year period; and
4. Milestone payments within the combined expenses are as follows:
 - (i) AUD 100,000 upon the grant of licenses to all the properties;
 - (ii) AUD 1,000,000 upon the completion of the first drill hole on the Walker Gossan project (paid); and
 - (iii) AUD 4,000,000 upon the completion of a resource study that shows an indicated status for a minimum of 20 million tons of greater than 8% combined lead and zinc, or lead, zinc, and silver, within the licensed area or a Decision to Mine being made.

Stage Two

GPM may increase its interest to 75% by completing a Feasibility Study within three years of completing Stage One. Rio Tinto may elect to contribute according to its participating share or not contribute and be diluted or convert its interest into a Net Smelter Return (2.5%) royalty. There are rights of first refusal on the purchase and sale of interest for both parties at fair market value. GPM will be responsible for all negotiations with the Northern Land Council for consent to issue the exploration license applications and work programs to be conducted by GPM under its sole rights or as an operator.

During 2022 GPM Metals conducted a review of the work completed at the Walker Gossan project located in East Arnhem Land in the Northern Territory of Australia. This review included reinvestigating the previous geological mapping, a reappraisal of the geochemical sampling, and the drill core completed in 2016. GPM personnel believes they drilled into the iron-rich outer halo to a potential primary mineralized system in 2016.

As a result of the analysis of the 2016 drill program, GPM has identified two areas for further investigation. A Thallium anomaly in the northern area within the existing approved tenement and an unapproved area to the west of the previous drill program.

The area to the west is contained in Exploration Area 30956 (ELA 30956). During 2022 GPM Metals initiated an application process to obtain a permit to explore this area. The Northern Land Council (NLC) facilitated an initial consultation with the Traditional Land Owners in September 2021. GPM obtained partial consent to negotiate access to this area.

6. Selected three and nine months ended financial information

(A) Financial performance

The net loss for the nine months ended September 30, 2022, consisted primarily of (i) general and administrative expenses of \$189,302 and (ii) exploration and evaluation expenses of \$105,186. This was decreased by a foreign exchange loss of \$92, a fair value adjustment on short-term investments of \$6 gain, and an interest income of \$1,621.

As the Company has no revenue, its ability to fund its operations depends upon securing financing through the sale of equity or assets. See "Risk Factors" below.

7. Discussion of operations

Three months ended September 30, 2022, compared with three months ended September 30, 2021

The Company's net loss totaled \$153,860 for the three months ended September 30, 2022, with primary and diluted loss per share of \$0.002. This compares with a net loss of \$134,075 with a basic and diluted loss per share of \$0.002 for the three months ended September 30, 2021. The net loss of \$19,785 was principal:

- Total operating activities in Q3 2022 were \$67,154 compared to \$75,684 in Q3 2021, a decrease of \$8,530. Most of the reduced amount is due to no share-based compensation payment in Q3 2022.
- In Q3 2022, the Company exploration expense totaled \$88,556, including a \$78,823 indigenous liaison fee to Northern Land Council and some miscellaneous expenses. In Q3 2021, the Company paid a total of \$67,477, primarily is \$55,597 indigenous liaison fee, to Northern Land Council.
- Stock-based compensation is nil for September 30, 2022 (September 30, 2021-\$19,602).
- Salaries and benefits were \$33,028 in Q3 2022, compared to \$27,849 in Q3 2021, an increase mainly due to Australian GST charged on the bill.
- Reporting issuer costs in Q3 2022 were \$4,309 compared to \$2,620 in Q3 2021, an increase of \$1,689 because of a private placement in July 2022.
- Administrative and general expenses increased to \$8,438 for September 2022 compared to \$2,605 in September 2021, mainly due to the change of sublease amount of office rental fee.
- Accretion expense was reduced to \$-101 in Q3 2022 from \$1,467 in Q3 2021 due to less lease term remaining and lease amount adjustment from the vendor.
- All other expenses related to general working capital.

8. Liquidity and capital resources

The activities of the Company, principally the acquisition and exploration of properties prospective for minerals, are financed through the completion of equity transactions such as equity offerings and the exercise of stock options and warrants. There is no assurance that future equity capital will be available to the Company in the amounts or at times desired by the Company or on terms that are acceptable to it, if at all. See "Risk Factors" below and "Trends" above.

The Company has no operating revenues and, therefore, must utilize its current cash reserves, funds obtained from the exercise of warrants and stock options, and other financing transactions to maintain its capacity to meet ongoing operating activities. As of September 30, 2022, the Company had 76,029,059 common shares issued and outstanding, 10,456,250 warrants, and 3,150,000 options outstanding that would raise \$1,510,625 if exercised in full. This is not anticipated in the immediate future. See "Trends" above.

8. Liquidity and capital resources continued

On September 30, 2022, the Company had cash of \$317,970 (June 30, 2021 - \$54,886). Amounts payable and other liabilities were \$39,594 on September 30, 2022, compared to \$122,672 on September 30, 2021. The number of liabilities includes both short-term and long-term lease liabilities.

Cash used in operating activities was \$96,245 for the period of September 30, 2022, compared to \$-10,885 for the period of September 30, 2021. Operating activities for the period of September 30, 2022, were affected by a net change in non-cash working capital because of a decrease in the amount payable and other liabilities of \$12,280; and an increase in Accounts receivable and other assets of \$35,644.

The Company's liquidity risk from financial instruments is minimal as excess cash is held in current bank accounts.

The Company's use of cash is currently and is expected to continue to be focused on two principal areas, namely, the funding of its general and administrative expenditures and the funding of its exploration and evaluation activities. Exploration and evaluation activities include the cash components of the cost of acquiring and exploring the Company's mineral claims. For the third three-month period ending September 30, 2022, corporate head office costs are estimated to average less than \$65,000 per quarter. The \$65,000 covers salaries and benefits, consulting fees, administrative and general reporting issuer costs, accounting fees, professional fees, and insurance.

In addition, the Company is performing care and maintenance at its Walker Gossan project in Australia.

While the Company has no source of revenue, it believes it has sufficient cash resources to meet its administrative overhead for the next twelve months, starting from September 30, 2022, depending on future events. However, the Company will need to raise additional financing to meet future expenditures, including the Technical Report exploration budget. Although the Company has successfully raised funds to date, there can be no assurance that adequate funding will be available in the future or under terms favorable to the Company. See "Risk Factors" below and "Trends" above.

9. Financial instruments

The Company's activities expose it to various financial risks: credit risk, liquidity risk, and market risk (including foreign currency risk and equity price risk).

The Company's management team carries out risk management with guidance from the Audit Committee under policies approved by the Board of Directors. The Board of Directors also provides regular guidance for overall risk management.

Salaries and benefits include salaries, director fees, and fees to related companies controlled by select key management personnel.

During the September 30, 2022 quarter, the Company received payments in connection with a sub-lease agreement totaling \$46,028 (September 30, 2021 - \$25,210) from related parties (note 8).

The above-noted transactions are in the ordinary course of business and are measured at the exchange amount, as agreed to by the parties, and approved by the Board of Directors in strict adherence to conflict of interest laws and regulations.

10. Risk factors

Investing in the Company's securities is highly speculative and involves numerous significant risks. Such investment should be undertaken only by investors whose financial resources are sufficient to enable them to assume such risks and who have no need for immediate liquidity in their investments. Prospective investors should carefully consider the risk factors described below.

(A) Exploration, Development, and Operating Risks

Mining and exploration operations generally involve a high degree of risk. The Company's operations are subject to all the hazards and risks usually encountered in the exploration, development, and production of minerals, including unusual and unexpected geologic formations, seismic activity, rock bursts, cave-ins, flooding, and other conditions involved in the drilling and removal of material, any of which could result in damage to, or destruction of, mines and other producing facilities, damage to life or property, environmental damage and possible legal liability. Although adequate precautions to minimize risk will be taken, milling operations are subject to hazards such as equipment failure or failure of retaining dams around tailings disposal areas, which may result in environmental pollution and consequent liability.

The exploration for and development of mineral deposits involves significant risks that may not be eliminated even with a combination of careful evaluation, experience, and knowledge. While the discovery of minerals may result in substantial rewards, few properties that are explored are ultimately developed into producing mines. Significant expenses may be required to locate and establish mineral reserves, develop metallurgical processes, and construct mining and processing facilities at a particular site. It is impossible to ensure that the exploration or development programs planned by the Company will result in a profitable commercial mining operation. Whether a mineral deposit will be commercially viable depends on several factors, some of which are: the particular attributes of the deposit, such as quantity and quality of the minerals and proximity to infrastructure; highly cyclical mineral prices; and government regulations, including regulations on costs, taxes, royalties, land tenure, land use, importing and exporting of minerals, and environmental protection. The exact effect of these factors cannot be accurately predicted, but the combination of these factors may result in the Company not receiving an adequate return on invested capital.

10. Risk Factors Continuing

There is no certainty that the expenditures made by the Company on the search for and evaluation of minerals will result in discoveries of commercial quantities of ore or other minerals.

(B) Land Title

Although the title to the properties in which the Company holds an interest was reviewed by or on behalf of the Company, no formal title opinions were delivered to the Company. Consequently, no assurances can be given that no title defects affect such properties. Title insurance is generally unavailable, and the Company's ability to ensure that it has obtained secure claims to individual mineral properties or mining concessions may be severely constrained. The Company has not conducted surveys of the rights in which it holds direct or indirect interests; therefore, the precise area and location of such claims may be in doubt. Accordingly, the Company's mineral properties may be subject to prior unregistered liens, agreements, transfers, or claims, and title may be affected by, among other things, undetected defects.

(C) Competition May Hinder Corporate Growth

The mining industry is competitive in all of its phases. The Company faces intense competition from other mining companies for the acquisition of properties producing or capable of producing economic minerals. Many of these companies have more significant financial resources, operational experience, and technical capabilities than the Company. As a result of this competition, the Company may be unable to maintain or acquire attractive mining properties or skilled resources on terms it considers acceptable or at all. Consequently, the Company's revenues, operations, and financial condition could be materially adversely affected.

(D) Additional Capital

The development and exploration of the Company's properties may require substantial additional financing. Failure to obtain sufficient financing may result in the delay or indefinite postponement of exploration, development, or production on any or all the Company's properties or even a loss of property interest. There can be no assurance that additional capital or other types of financing will be available if needed or that, if available, the terms of such financing will be favorable to the Company.

10. Risk Factors Continuing

(E) Commodity Prices

The price of the common shares of the Company, the Company's financial results, and exploration, development, and mining activities may, in the future, be significantly adversely affected by declines in the price of minerals. Mineral prices fluctuate widely and are affected by numerous factors beyond the Company's control, such as the sale or purchase of minerals by various central banks and financial institutions, interest rates, exchange rates, inflation or deflation, fluctuation in the value of the United States dollar and foreign currencies, global and regional supply and demand, and the political and economic conditions of major mineral-producing countries throughout the world. The price of minerals has fluctuated widely in recent years, and severe future price declines could cause continued development of the Company's properties to be impracticable. Future production from the Company's properties depends on adequate mineral prices to make these properties economic.

In addition to adversely affecting the Company's reserve and resource estimates and its financial condition, declining commodity prices can impact operations by requiring a reassessment of the feasibility of a particular project. Such a reassessment may result from a management decision or may be required under financing arrangements related to a specific task. Even if the project is ultimately determined to be economically viable, the need to conduct such a reassessment may cause substantial delays or may interrupt operations until the reassessment can be completed.

(F) Exchange Rate Fluctuations

Exchange rate fluctuations may affect the Company's costs in its operations. Accordingly, a change in the currency the Company operates relative to the Canadian dollar would negatively impact the Company.

(G) Government Regulation

The mining, processing, development, and mineral exploration activities of the Company are subject to various laws governing prospecting, development, production, taxes, labor standards and occupational health, mine safety, toxic substances, land use, water use, land claims of local people, and other matters.

10. Risk Factors Continuing

Exploration may also be affected in varying degrees by government regulations concerning. Still, not limited to, restrictions on future exploration and production, price controls, export controls, currency availability, foreign exchange controls, income taxes, delays in obtaining or the inability to obtain necessary permits, opposition to mining from environmental and other non-governmental organizations, limitations on foreign ownership, expropriation of property, ownership of assets, environmental legislation, labor relations, restrictions on repatriation of income and return of capital, restrictions on mineral exports, high rates of inflation, increased financing costs, and site safety. This may affect the Company's ability to undertake exploration and development activities on the present and future properties in the manner contemplated and its ability to continue to explore, develop and operate those properties in which it has an interest or for which it has obtained exploration and development rights to date.

Although the Company believes that its exploration and development activities are currently carried out in accordance with all applicable rules and regulations, no assurance can be given that new laws and regulations will not be enacted or that existing rules and regulations will not be applied in a manner which could limit or curtail development or future potential production. Amendments to current laws and regulations governing operations and activities of mining and milling or more stringent implementation could have a substantial adverse impact on the Company.

(H) Political Risks

On September 30, 2022, all of the Company's operations were conducted in Canada, Barbados, and Australia, and as such, are exposed to various levels of political, economic, and other risks and uncertainties. These risks and uncertainties vary from country to country and include, but are not limited to, currency exchange rates; high rates of inflation; labor unrest; renegotiation or nullification of existing concessions, licenses, permits, and contracts; changes in taxation policies; restrictions on foreign exchange; and changing political conditions; currency controls and governmental regulations that favor or require the awarding of contracts to local contractors or require foreign contractors to employ citizens of, or purchase supplies from, a particular jurisdiction.

Future political actions cannot be predicted and may adversely affect the Company. Changes, if any, in mining or investment policies or shifts in political attitude in the countries of Canada, Barbados, or Australia, after September 30, 2022, may adversely affect the Company's business, results of operations, and financial condition. Future operations may be involved in varying degrees by government regulations concerning, but not limited to, restrictions on production, price controls, export controls, currency remittance, income taxes, foreign investment, maintenance of claims, environmental legislation, land use, land claims of local people, water use and mine safety. The possibility that future governments may adopt substantially different policies, extending to the expropriation of assets, cannot be ruled out.

Failure to comply strictly with applicable laws, regulations, and local practices relating to mineral rights applications and tenure, could result in loss, reduction, or expropriation of entitlements. The occurrence of these various factors and uncertainties cannot be accurately predicted and could have an adverse effect on the Company's consolidated business, results of operations, and financial condition.

10. Risk factors continued

(I) Labor and Employment Matters

While the Company has good relations with its employees, these relations may be impacted by changes in the labor relations scheme, which may be introduced by the relevant governmental authorities in whose jurisdictions the Company carries on business. Adverse changes in such legislation may have a material negative effect on the Company's business, results of operations, and financial condition.

(J) Subsidiaries

The Company conducts certain of its operations through its subsidiaries and holds certain of its assets through its subsidiaries. Accordingly, any limitation on transferring cash or other assets between the Company and its subsidiaries could restrict the Company's ability to fund its operations efficiently. Any such restrictions, or the perception that such limitations may exist now or in the future, could have an adverse impact on the Company's valuation and stock price.

(K) Market Price of Common Shares

Securities of micro and small-cap companies have experienced substantial volatility in the past, often based on factors unrelated to the financial performance or prospects of the companies involved. These factors include macroeconomic developments in North America and globally and market perceptions of the attractiveness of industries. The Company's share price is also likely to be significantly affected by short-term changes in mineral prices or in its financial condition or results of operations, as reflected in its quarterly earnings reports. Other factors unrelated to the Company's performance that may affect the price of the common shares include the following: the extent of analytical coverage available to investors concerning the Company's business may be limited if investment banks with research capabilities do not continue to follow the Company; lessening in trading volume and general market interest in the Company's securities may affect an investor's ability to trade significant numbers of common shares; the size of the Company's public float may limit the ability of some institutions to invest in the Company's securities; and a substantial decline in the price of the common shares that persists for a significant period could cause the Company's securities to be delisted from the exchange on which they trade, further reducing market liquidity.

Because of these factors, the common shares' market price at any given time may not accurately reflect the Company's long-term value. Securities class action litigation often has been brought against companies following periods of volatility in the market price of their securities. The Company may, in the future, be the target of similar litigation. Securities litigation could result in substantial costs and damages and divert management's attention and resources.

10. Risk Factors Continuing

(L) Future Sales of Common Shares by Existing Shareholders

Sales of a large number of common shares in the public markets, or the potential for such sales, could decrease the trading price of the common shares and could impair the Company's ability to raise capital through future sales of common shares. The Company has previously completed private placements at prices per share, which are from time to time lower than the market price of the common shares. Accordingly, a significant number of shareholders of the Company have an investment profit in the Common Shares that they may seek to liquidate.

(M) Key Executives

The Company depends on crucial executives' services, including the CEO of the Company and a small number of highly skilled and experienced executives and personnel. Due to the relatively small size of the Company, the loss of these persons or the Company's inability to attract and retain additional highly skilled employees may adversely affect its business and future operations.

(N) Conflicts of Interest

Certain directors and officers of the Company also serve as directors and/or officers of other companies involved in natural resource exploration and development; consequently, there is the possibility for such directors and officers to be in a position of conflict. Any decision made by any of such directors and officers involving the Company will be made in accordance with their duties and obligations to deal fairly and in good faith with a view to the best interests of the Company and its shareholders. In addition, each of the directors must declare and refrain from voting on any matter in which such a director may have a conflict of interest under the procedures outlined in the *Business Corporations Act* (Ontario) and other applicable laws.

The Company's operations are subject to receiving and maintaining permits and licenses from appropriate governmental authorities from time to time. Although GPM currently has all required permits and licenses for its operations as presently conducted, there is no assurance that delays will not occur in connection with obtaining all necessary renewals of such permits and licenses for the existing operations or additional permits or licenses for all future new operations. Before any development on any of its properties, GPM must receive permits and licenses from appropriate governmental authorities. There can be no assurance that GPM will receive and hold all permits and licenses necessary to develop or continue operating at any particular property or that such licenses or permits awarded will not be canceled according to applicable legislation.

10. Risk factors continued

(O) Insurance and Uninsured Risks

GPM's business is generally subject to several risks and hazards, including adverse environmental conditions, industrial accidents, labor disputes, unusual or unexpected geological conditions, ground or slope failures, cave-ins, changes in the regulatory environment, and natural phenomena such as inclement weather conditions, floods, and earthquakes. Such occurrences could result in damage to mineral properties or production facilities, personal injury or death, environmental damage to the Company's properties or the properties of others, delays in exploration and development, monetary losses, and possible legal liability.

The Company currently maintains directors' and officers' liability insurance in such amounts as it considers reasonable. Accordingly, the Company's insurance does not cover the potential risks associated with a mineral exploration company's operation. The Company may be unable to maintain insurance to cover these risks at economically feasible premiums. Insurance coverage may not continue to be available or may not be adequate to cover any resulting liability. Moreover, insurance against threats such as environmental pollution or other hazards due to exploration and production may not be generally available to GPM or other mineral exploration companies on acceptable terms. The Company might become liable for pollution or other hazards that may not be insured against or which GPM may elect not to insure against because of premium costs or other reasons. Losses from these events may cause GPM to incur high prices that could adversely affect its financial performance and the results of operations.

(P) Environmental Risks and Hazards

All phases of GPM's operations are subject to environmental regulation in the various jurisdictions in which it operates. These regulations mandate, among other things, the maintenance of air and water quality standards and land reclamation. They also set forth limitations on the generation, transportation, storage, and disposal of solid and hazardous waste. Environmental legislation is evolving in a manner which will require stricter standards and enforcement, increased fines and penalties for non-compliance, more stringent environmental assessments of proposed projects and a heightened degree of responsibility for companies and their officers, directors, and employees. There is no assurance that future changes in environmental regulation, if any, will not adversely affect the Company's operations. Environmental hazards may exist on the properties on which GPM holds interests unknown to the Company and caused by previous or existing owners or operators of the properties. Government approvals and permits are currently and may be required in connection with the Company's operations. To the extent such permissions are required and not obtained, the Company may be curtailed or prohibited from proceeding with planned exploration or development of mineral properties.

Failure to comply with applicable laws, regulations, and permitting requirements may result in enforcement actions thereunder, including orders issued by regulatory or judicial authorities causing operations to cease or be curtailed, and may include corrective measures requiring capital expenditures, installation of additional equipment, or remedial actions. Parties engaged in the exploration or development of mineral properties may be required to compensate those suffering loss or damage because of the mineral exploration activities. They may have civil or criminal fines or penalties imposed for violations of applicable laws or regulations.

10. Risk factors continued

Amendments to current laws, regulations, and permits governing operations and activities of mining and mineral exploration companies, or more stringent implementation thereof, could have a material adverse impact on the Company and cause increases in exploration expenses or capital expenditures or require abandonment or delays in the development of new mineral exploration properties.

(Q) Infrastructure

Mineral exploration, processing, development, and related activities depend, to one degree or another, on adequate infrastructure. Reliable roads, bridges, power sources, and water supply are essential determinants affecting capital and operating costs. Unusual or infrequent weather phenomena, sabotage, and government or other interference in the maintenance or provision of such infrastructure could adversely affect the Company's operations, financial condition, and results of operations.

(R) No History of Mineral Production

GPM has never had any interest in mineral-producing properties. There is no assurance that commercial quantities of minerals will be discovered at any of the Company's current or future properties, nor is there any assurance that the Company's exploration programs will yield any positive results. Even if commercial quantities of minerals are discovered, there can be no assurance that any of the Company's properties will ever be brought to a stage where mineral resources can profitably be produced thereon. Factors that may limit the Company's ability to produce mineral resources from its properties include, but are not limited to, the price of the mineral resources for which the Company is exploring, availability of additional capital and financing, and the nature of any mineral deposits.

11. Disclosure of internal controls

Management has established processes to provide them with sufficient knowledge to support representations that they have exercised reasonable diligence to ensure that (i) the consolidated financial statements do not contain any untrue statement of material fact or omit to state a material fact required to be stated or that is necessary to make a statement not misleading in light of the circumstances under which it is made, as of the date of and for the periods presented by the consolidated financial statements; and (ii) the consolidated financial statements lawfully present in all material respects the financial condition, financial performance and cash flows of the Company, as of the date of and for the periods presented and (iii) by following IFRS – IAS 21 Determination of functional currency of an investment holding company: the Company has been used Canadian dollar as its functional currency to file its consolidated financial statement, since the Company has hold DPG Resources Australia Pty in Australia, and Guyana Precious Metals in Barbados.

In contrast to the certificate required for non-venture issuers under National Instrument 52-109 Certification of Disclosure in Issuers' Annual and Interim Filings ("NI 52-109"), the Venture Issuer Basic Certificate filed by the Company does not include representations relating to the establishment and maintenance of disclosure controls and procedures ("DC&P") and internal control over financial reporting ("ICFR"), as defined in NI 52-109. In particular, the certifying officers filing such certificates are not making any representations relating to the establishment and maintenance of:

(A) Controls and other procedures designed to provide reasonable assurance that information required to be disclosed by the issuer in its annual filings, interim filings, or other reports filed or submitted under securities legislation is recorded, processed, summarized, and reported within the periods specified in securities legislation; and

(B) A process to provide reasonable assurance regarding the reliability of financial reporting and preparing financial statements for external purposes following the issuer's generally accepted accounting principles (IFRS).

The Company's certifying officers are responsible for ensuring that processes are in place to provide them with sufficient knowledge to support their representations in such a certificate. Investors should be aware that inherent limitations on the ability to certify officers of a venture issuer to design and implement on a cost-effective basis DC&P and ICFR as defined in NI 52-109 may result in additional risks to the quality, reliability, transparency, and timeliness of interim and annual filings and other reports provided under securities legislation.

12. Strategic update

(A) Exploration prospects

The COVID-19 epidemic in the Northern Territory broke out in early 2022. The Northern Land Council (NLC) has adopted a cautious approach and has postponed all meetings with Traditional Land Owners until further notice.

The Northern Land Council (NLC) has been working on the Anthropology Survey of the community on behalf of GPM's proposal, which is in the last stage of completion.

Further discussions with the NLC indicate that this final meeting will not occur this year as the wet season has begun, and access will soon be limited.

GPM has commenced discussions with the NLC with a view to obtaining a commitment for a final meeting with Traditional Landowners in April 2023.
